



Official Rules for NCATS Holiday Hunt 2024:

Please carefully read and consider the following rules before entering our NCATS Holiday Hunt. Entering gives you a chance to win but does not guarantee a win. Participants will be eligible to participate beginning November 30, 2024, 4 PM EST until December 14, 2024, 9 PM EST.

To Participate:

To participate in the NCATS Holiday Hunt, entrants must join the NCATS Holiday Hunt Facebook group. Clues will be posted in the Facebook group, guiding participants to locate the “hidden” NCATS glowing orb on the following dates: November 30, December 6, 7, 13, and 14. Participants should use the provided clues to aid in their search during these specified dates.

Participants must read and agree to NCATS sweepstakes rules.

Ways to Win:

Grand Prizes

The first participant to find and touch the hidden NCATS glowing orb will be awarded a ticket to redeem their grand prize at the NCATS office. Upon presenting their ticket at the front desk, the winner will select a box from beneath the NCATS Christmas tree, each of which contains a card designating one of the available grand prizes. By accepting their prize, the winner consents to NCATS recording a video of the unboxing for promotional purposes.
